## TERMS AND CONDITIONS

THE WILDEST RUMPUS LTD is a supplier of recreational services. The recreational services include participation in slack-lines, swinging, muddy play and low height tree climbing and a fire pit ("recreational activities"). By purchasing a ticket for or by using any of the facilities at THE WILDEST RUMPUS LTD you agree to be bound by these conditions.

We at THE WILDEST RUMPUS LTD believe that children should be supported in taking part in activities where they learn about their own bodies, their abilities and learn to take small risks in a supervised environment. This is because when learning about risks we, as their grown ups, have an understanding of limits and abilities. Our waiver is to ensure that accompanying adults to THE WILDEST RUMPUS LTD keep this in mind.

1) I hereby agree and promise to accept and assume all of the risks existing in these activities. Participation in these is purely voluntary and we elect to participate in spite of the risks.

2) I acknowledge that participation in the THE WILDEST RUMPUS LTD activities provided entails, known and unknown risks that could result in physical or emotional injury, paralysis, death or damage to themselves or third parties. I further acknowledge that the activities provided by THE WILDEST RUMPUS LTD require a reasonable level of fitness and ability.

3) I acknowledge that I have been provided with the necessary safety instructions by THE WILDEST RUMPUS LTD in relation to the activities and warrant that I will comply with these at all times whilst on the premises from which the activities will be carried out.

4) I agree that I will only allow my child to climb/balance within their ability and of which I am able to retain control of at all times. If children are climbing they climb no higher than my own head height and climb at their own risk.

5) I acknowledge that THE WILDEST RUMPUS LTD is a completely outside space, therefore open to the elements and all that nature has to offer including things such as insect bites, stings, brambles, sticks, inedible plants/flowers/ fungus. Whilst THE WILDEST RUMPUS LTD have removed and minimised as many hazards as possible it remains a natural space therefore your child remains your responsibility and under your supervision at all times.

6) I have read the information given on Lyme disease <https://www.nhs.uk/conditions/lyme-disease/>

7) I hereby agree and promise to accept the guidance from the staff at THE WILDEST RUMPUS LTD concerning fires. I am aware that it is my responsibility to ensure my child/ward adheres to these safety rules and only approaches the fire with an adult when a member of staff has authorised it.

8) I agree as an adult participant, or as the Parent/Legal Guardian of a minor participant, in consideration of being permitted to participate at THE WILDEST RUMPUS LTD, grant, THE WILDEST RUMPUS LTD permission to photograph me or my child(ren)/ward(s) in connection with THE WILDEST RUMPUS LTD use the photograph for advertising and promotional purposes. I waive any right to inspect or approve the use of the Photograph and/or Recording, and acknowledge and agree that the rights granted to this release are without compensation of any kind. If you would prefer that your child is not photographed please speak to a member of staff to sign our photos waiver.

9) I acknowledge that THE WILDEST RUMPUS LTD is not liable for damage or loss to myself, third parties or property however incurred whilst undertaking activities or on the event premises.

10) I acknowledge THE WILDEST RUMPUS LTD is not liable for damage to any vehicles parked on site during sessions.

11) If the participant is a minor, I agree that this Release of Liability and Assumption of Risk Agreement ("WAIVER / RELEASE") is made on behalf of that minor participant(s) and that all of the releases, waivers and promises herein are binding on that minor participant. I represent that I have full authority as Parent or Legal Guardian of the minor participant to bind the minor participant to this Agreement. I understand that if my child attends with an adult acting as loco parentis that they understand and are aware of their responsibilities.

12) I expressly agree and promise to accept all risk existing in the activities and acknowledge that participation in activities is voluntary. I elect to participate in spite of the risks. I agree to indemnify THE WILDEST RUMPUS LTD with its equipment suppliers and manufacturers, from any and all claims, demands or courses of action which are in any way connected with my participation in the activities.

13) In consideration of not being required to sign a fresh copy of this Waiver Release before each visit, I further agree that this Waiver Release shall apply to all visits within the next 12 months by me and by the minor participant in full.

14) To the maximum extent permitted by law, but subject to the non-excludable consumer guarantees implied pursuant to the UK Consumer Law, in no event will THE WILDEST RUMPUS LTD its employees, directors and agents be liable in respect of any claim for any indirect or consequential loss or damage including without limitation personal injury, financial loss (such as loss of profits or use of capital or revenue or otherwise), or for any punitive, exemplary, special, incidental or consequential loss or damage whether such liability arises in contract, tort (including negligence), equity, breach of statute or statutory duty or breach of any consumer guarantees.

15) This Waiver/Disclaimer will be governed by and construed in accordance with English law and any disputes relating to this disclaimer shall be subject to the exclusive jurisdiction of the courts of England.

**16) All allergies must be declared to The Wildest Rumpus prior to arrival.**
